After the change in the law, much of the fall semester was focused on updating the handbook and procedures and obtaining school board approval for the new policy. The new policy was posted on the district website in December, 2022. Minutes from May 19th meeting approved. District SEAC Handbook distributed.

Discussions:

District SEAC Handbooks were distributed for members to review. Questions were asked and answered about the purpose of the committee. Extended School Year Services were discussed along with IEPs. Parents expressed concerns about the level of understanding of ESYS and various parts of the IEP. It was suggested that the district conduct or partner with Families Helping Families to conduct parent education around IEPs, services, and ESYS. The committee chair will reach out to Families Helping Families to see if a representative can attend the next meeting. Another topic discussed was methods of communication. Parents suggested utilizing Facebook posts to share information to parents about upcoming events. JText was also mentioned as a preferred method of communication, even more preferred than notes sent home. The committee chair discussed how IDEA funds are budgeted and explained some of the restrictions that exist relative to federal funds. Parents were asked for feedback on budgeting. The next meeting was scheduled for June 20, 2023 at 8:30 am.
